

HOW TO OBTAIN YOUR NEVADA INSURANCE PRODUCERS LICENSE

Producer Requirements

To qualify for a resident Nevada state insurance producer license, the applicant must satisfy the following requirements:

- Must be 18 years of age or older
- Must be a resident of the state of Nevada
- Pass a written examination and file a license application online
- Submit a set of fingerprints to the FBI

Pre-License Education

Pre-licensing education is optional in the State of Nevada, those looking to acquire an insurance license have a greater chance of passing their licensing exam when they complete our Ace Insurance School's pre-licensing courses. Nevada Producer State Exam

To obtain a Nevada insurance Producers license, you must pass a state licensing exam for each line of authority. Ace Insurance School exam material is a comprehensive course to help students understand what to expect when taking the Nevada State exams. We will prepare you with the greatest chance of passing your state exam on your first attempt.

Effective January 1, 2020, Pre-licensing Education courses are no longer required for all insurance licenses. Pearson VUE exams are still required to qualify for Nevada Insurance licenses. Ace Insurance School will prepare with materials you need to pass the Nevada State Insurance licensing exam.

Nevada Insurance License Exam Requirements

Apply Online: new licensees can submit their application online by visiting sircon.com

1. **Schedule for the State Exam:** schedule online by visiting pearsonvue.com/nv or
2. call (800) 274-2609.

State Exam fees:

1. One line of Authority = \$51.00
2. Two lines of Authority = \$61.00

Documents Required to Apply: Candidates must present two forms of current signature identification. The name on the identification must exactly match the name on the registration. The primary identification must be government issued and photo-bearing with a signature, and the secondary identification must contain a valid signature. Identification must be in English. Exam Format: Applicants must pass the state licensing exam with a 70% or higher score to file for a license application.

3. **File license application:** License application can be submitted online through Sircon.com. Once you have submitted your application to the Division, you should log back into the application system using your candidate transaction number to attach supporting documentation to your online application.
4. **Fingerprinting Process:** Applicants Must have an FBI background check to obtain clearance to apply for an insurance license.

The fingerprinting fee is \$55.00.

Non-Resident Nevada Pre-License Exam Prep Requirements

Non-Resident Applicants must be licensed and in good standing in their home state for all lines for which you are applying. All applicants must submit an online application and pay the licensing fees. This can be done through the Sircon.com website.
